MM raised that we ought to consider SAC's - Special Areas of Conservation, which has recently been raised by Wealden District Council in several recent planning applications where WDC have strongly objected due to the nitrate & nitrogen dioxide levels in the air at Ashdown Forest, as the nitrates are having a huge detrimental effect on the flora & fauna on Ashdown Forest.

Locally, both Ashdown Forest and Pevensey Levels are SAC's.

SAC's are protected under EU law and are supported by Natural England, and so should be considered.

Due to the recent objections by WDC, RDC are currently considering their options on the way forward on the planning applications in question.
