1. Introduction

This document lists the potential building sites offered by land owners and developers as a result of the Call for Sites and subsequently offered, up to the current date of this document. These sites may have also been included in the SHLAA sites listing, NP Green spaces and Community Valued Assets listings, so cross referencing may be needed.

Within this listing a number of sites are included because a landowner or developer has identified an area of land that is different to that used in the SHLAA list/map.

2. Numbering system

In order to use a comprehensive/unique site numbering system within <u>all</u> NP documents the RDC - SHLAA potential building site numbers have been retained (e.g. NE 07). Other codes are used to designate sites with differing characteristics (e.g. proposed Green space allocation), therefore an individual site may have more than one number used on various maps.

Extra building sites considered as a result of the call for sites and since, to date, are numbered thus:

NE NS101, NE NS102,... = Netherfield New Sites number series – not priority ordered BA NS101, BA NS102,... = Battle New Sites number series – not priority ordered
