

## 1. Introduction

- 1.1. The Battle Civil Parish (CP) Neighbourhood Plan (NP) Steering Group, having heard of a Planning Application in another District Council area that had been accepted on land that locals thought was Green Space and would not be built upon, decided that an analysis of Battle CP to identify Local Green Spaces (LGS) and potentials for some form of registration was an essential part of the NP. Initially an extensive Civil Parish-wide green infrastructure survey was undertaken (see Green Infrastructure Report 2018-Dec.)
- 1.2. A candidate Local Green Spaces (LGS) list was then developed and considered, by the NP Steering Group on 2017-02-01, subsequently several versions have been produced as knowledge grew.
- 1.3. The list is focussed on LGS, however expert advice is required to make a determination about how they should be categorised for protection: such as an Asset of Community Value classification, a Common Land, a Village Green etc. Indeed some sites already have significant protections (e.g. GS12 which is within the registered ancient battlefield site). Nevertheless the community desire is to highlight *all* sites, to provide an overall view of the importance of LGS within the CP.
- 1.4. Subsequently an LGS Designation Candidates list was drawn up – issued in v6.1 of this document dated 2019-04-30, tabulated with reference to the National Planning Policy Framework criteria for LGS qualification. This enabled the NP Steering Group to determine that all the sites listed at that time met the three criteria (a, b, c) required by NPPF paragraph 100, thus:
  - a) in reasonably close proximity to the community it serves;
  - b) demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
  - c) local in character and is not an extensive tract of land.
- 1.5. The current list derives from a review begun in 2019-June to include information from landowners, where known; subsequently Land Registry inquiries have informed the list now delivered. As a result, a few sites were deleted because the site is a private property and/or the landowner expressed a positive statement that they do not want their site to be included into the NP considerations; each deletion was carefully considered and agreed by the Steering Group. However despite some landowner's wishes, the Steering Group has subsequently retained sites in the list because of their over-riding community importance. Deleted sites are no longer shown in the sections 5.1 and 5.2 and their maps have been deleted from Annex 6.
- 1.6. Sections 5.1 and 5.2 were added to the previous version (v7.5) to provide site ownership and justification narrative for the sites to be included in the NP.  
NOTE: Deletions from the previous Analysis list, as described (i.e. sites GS14, 21, 22, 24, 26 and 27), results in some now unused site numbers that do not appear in sections 5.1 and 5.2 that list the sites for NP inclusion.

## 2. Current List of Local Green Spaces

- 2.1. The current list of Local Green Spaces has been elaborated since the candidate list which considered local concerns for small green spaces. The Battle CP Boundary map (see Annex 1) shows the three 'large-area' Green Spaces within the CP: Darwell Wood, Great Wood and Beauport Park, which each have a number of protections and provide important recreational facilities, as well as their environmental significance. The current LGS list is now more precisely described and listed below, roughly north-west to south-east and recent additions have been included.
- 2.2. In order to use a comprehensive/unique site numbering system within all Battle CP NP documents the RDC - SHLAA potential building site numbers have been retained (e.g. NE 07). Other codes are used to designate sites with differing characteristics (e.g. proposed Green Space allocation), therefore an individual site may have more than one number used.
- 2.3 A specific NP set of numbers has been invoked for Green Spaces, numbered thus:  
NE GS 01, NE GS 02... = Netherfield Green Space number series – not priority ordered  
BA GS 01, BA GS 02... = Battle Green Space number series – not priority ordered

NOTE 1: Telham sites are included in the Battle number series (see also Annex 3).

NOTE 2: The "Battle Abbey" site under English Heritage management and very fully protected, is not herein listed.

## **6. Historic Farmsteads** (see Annex 2)

An important characteristic of the Civil Parish is that it contains many historic farmsteads and notably has an above average coverage of small farms that are typically half the national average farm area size. The NP Steering Group believe that the historic farmsteads and small farms structure shall be considered unsuitable for any housing development and that such land as remains should be encouraged to be kept and used as low-input farming.

## **7. Sites of environmental importance**

The CP has four Sites of Special Scientific Interest (SSSI) *within* its boundary:

7.1	Darwell Wood	37.6 Ha	mainly hornbeam coppice (PAWS)
7.2	River Line	1.87 Ha	geological value – inlier gorge
7.3	Blackhorse Quarry	0.19 Ha	geological value (adjacent to covered reservoir)
7.4	Hemingfold Meadow	4.9 Ha	meadow grasses and wildflowers

There are several other SSSIs in the proximity of the CP – all shall be afforded the maximum protection from any development as prescribed in current legislation, *including* ‘guard areas’ around them.

NOTE: The on-line DEFRA Magic map can be used to display the ‘guard areas’.

There could potentially be other sites within the CP, so far undesignated for their environmental importance – one is presently listed for further consideration to the HW-AONB:

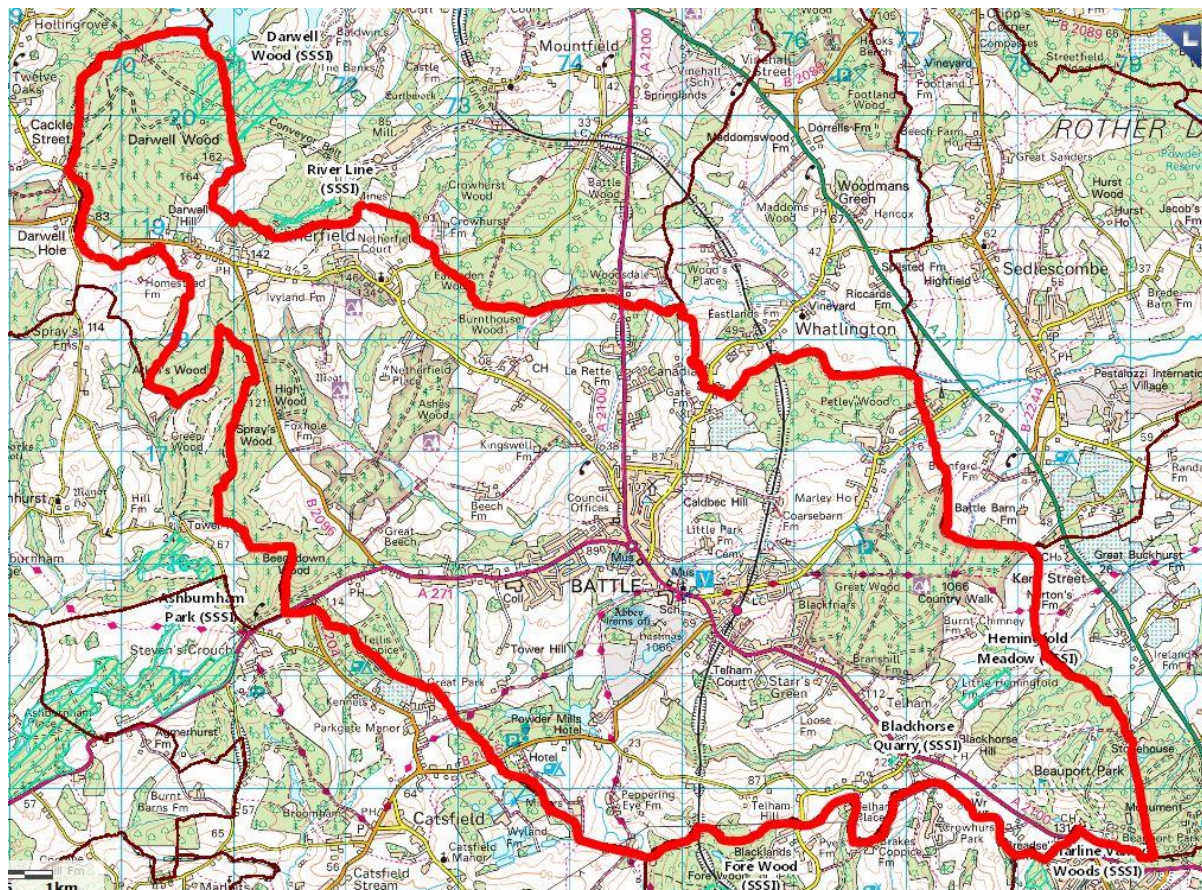

## **8. Ancient Woodland** (see Annex 3)

Battle CP has a high percentage of woodland by national averages, much of which is designated as Ancient Woodland and has AONB Management Plan objective W1 status – namely that it should be maintained as ancient woodland. Many of the woods maybe so-called Plantation on Ancient Woodland Sites (PAWS), nevertheless they contain species rich ecology that provides both recreation and small scale commercial activity. Without exception the NP Steering Group believe that no housing development should be permitted in these woodland areas.

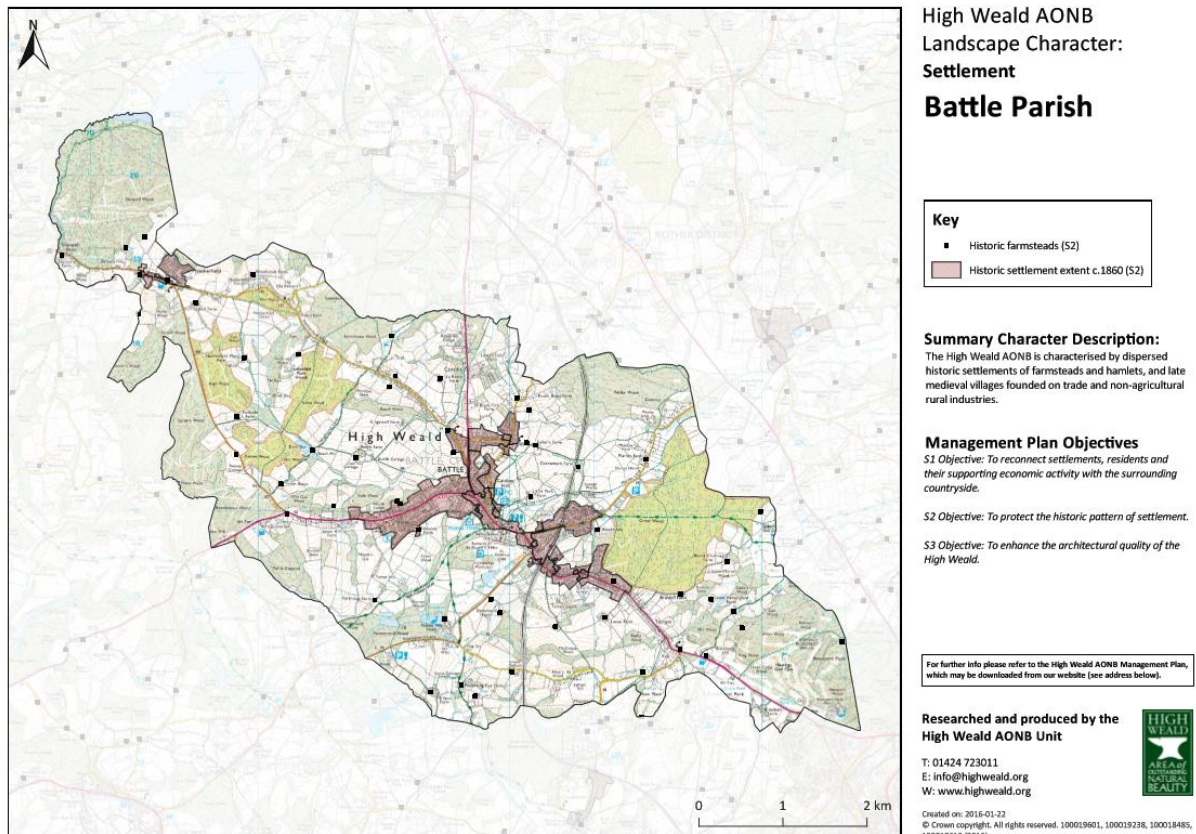
**Annex 1: Battle Civil Parish – boundary** (shown superimposed on OS map)

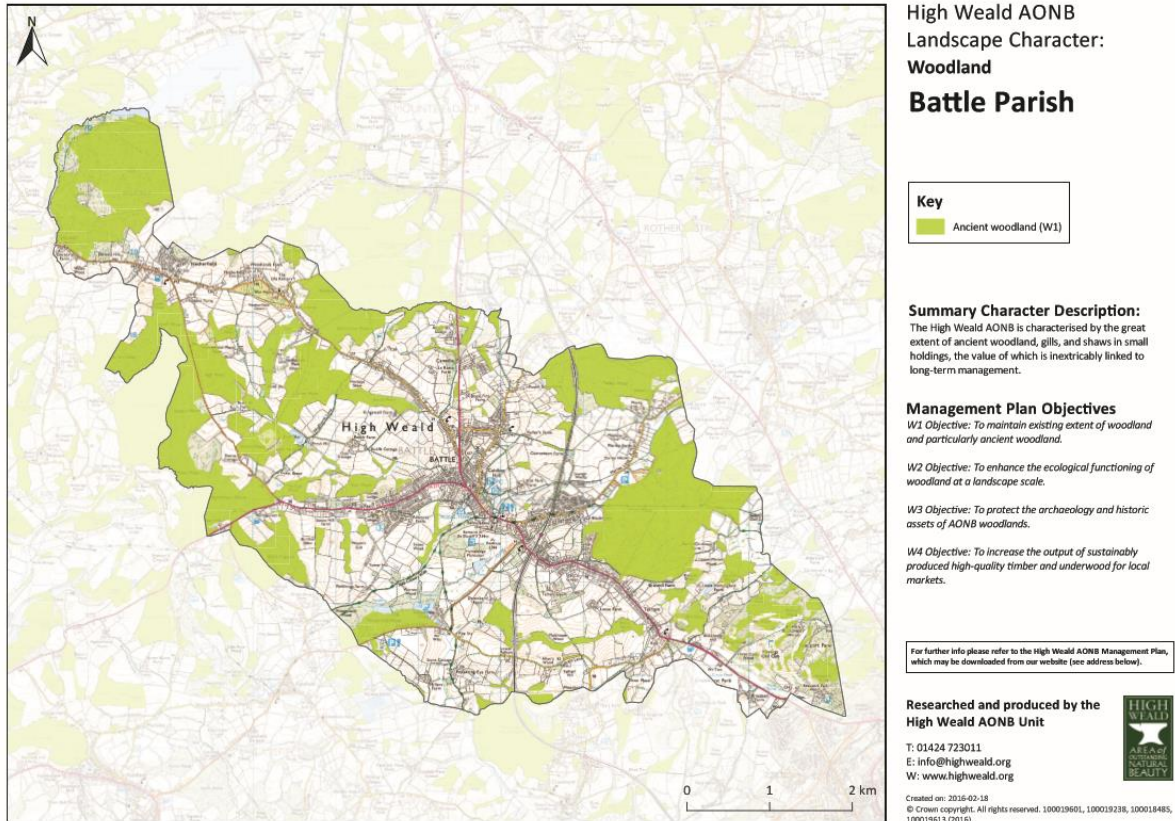

## Annex 3: Ancient Woodland

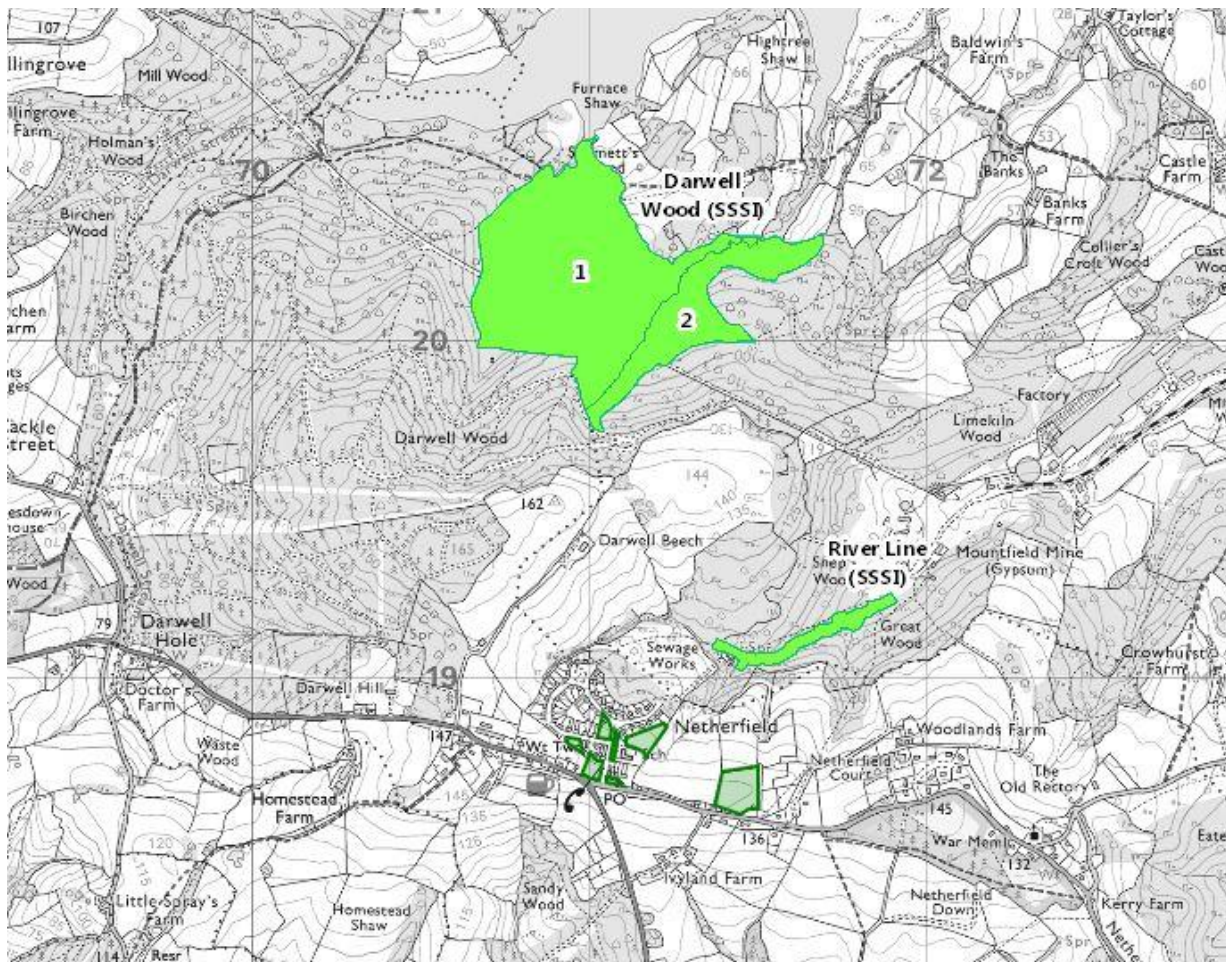


NOTE: Battle Great Wood is marked on the map as ancient woodland. It is classified as a Plantation on an Ancient Woodland Site (PAWS) – i.e. the site is believed to have been continuously wooded since at least 1600AD. Even though it has been re-planted at various times in its history and is now not all Ancient Semi-Natural Woodland (ASNW), it nevertheless falls under the overall ancient woodland umbrella (PAWS + ASNW).

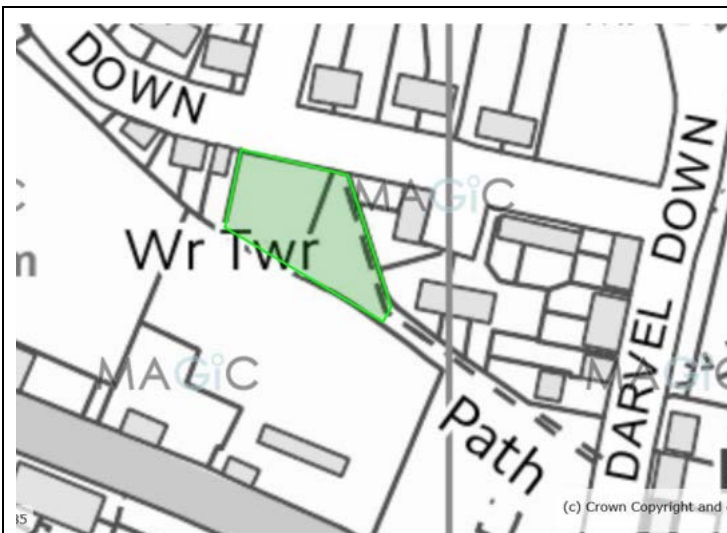

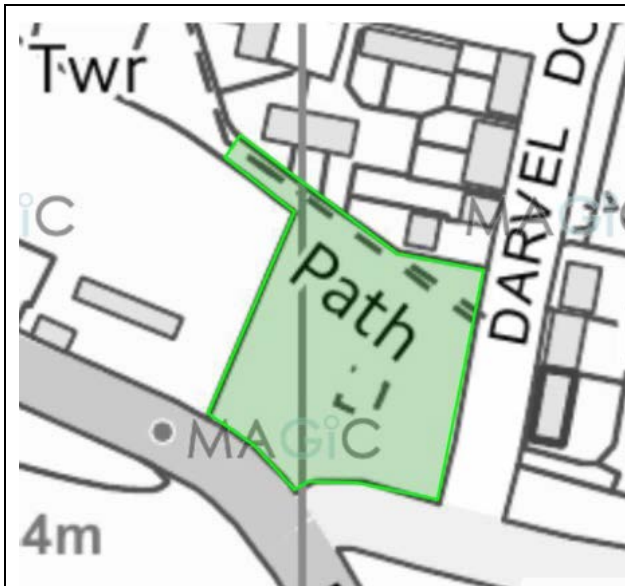



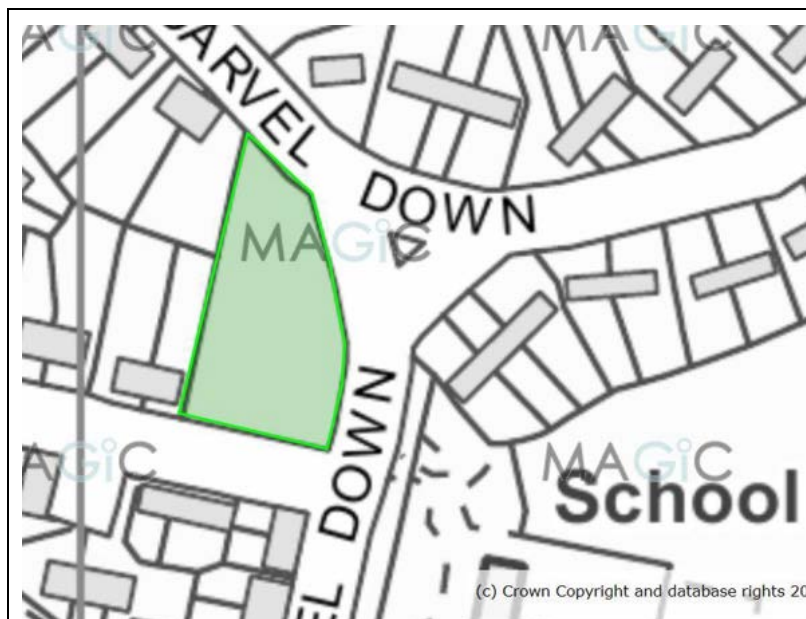



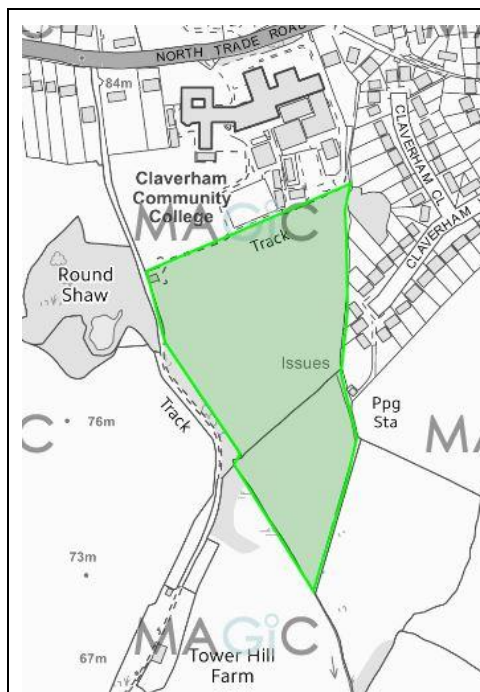

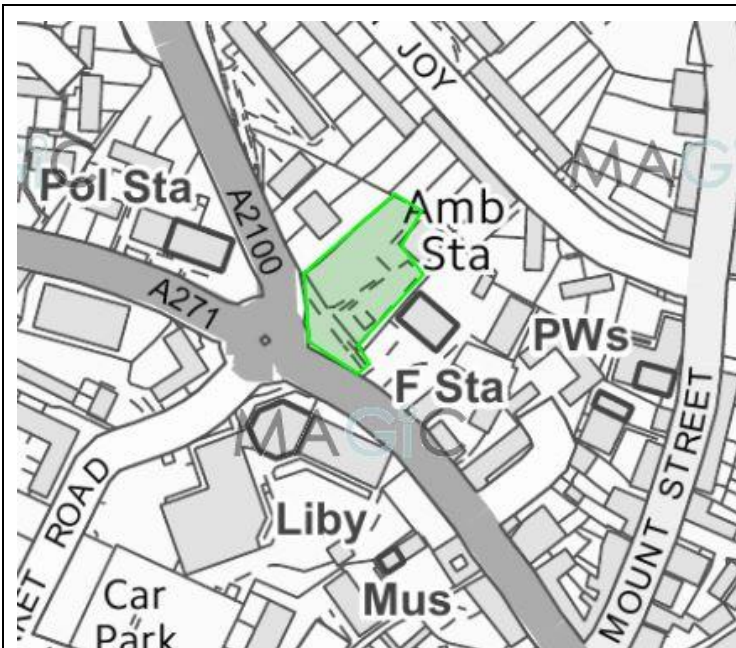

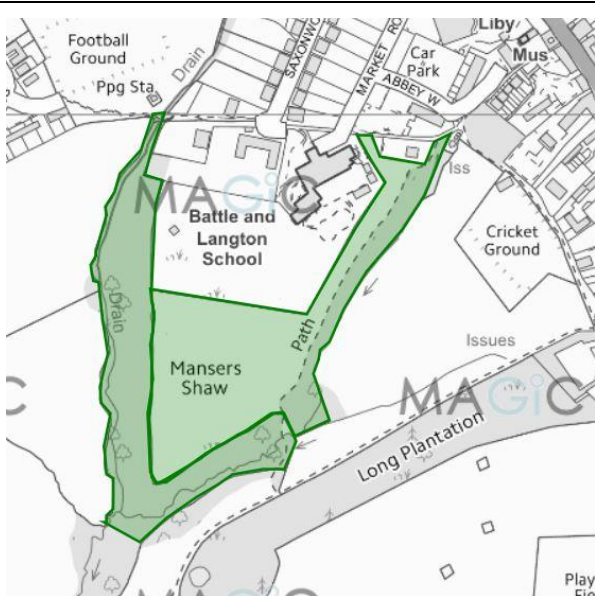

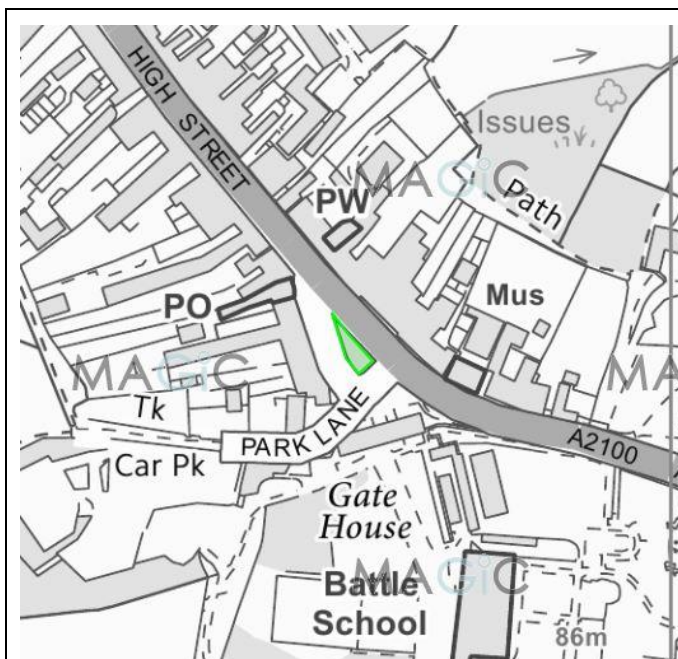

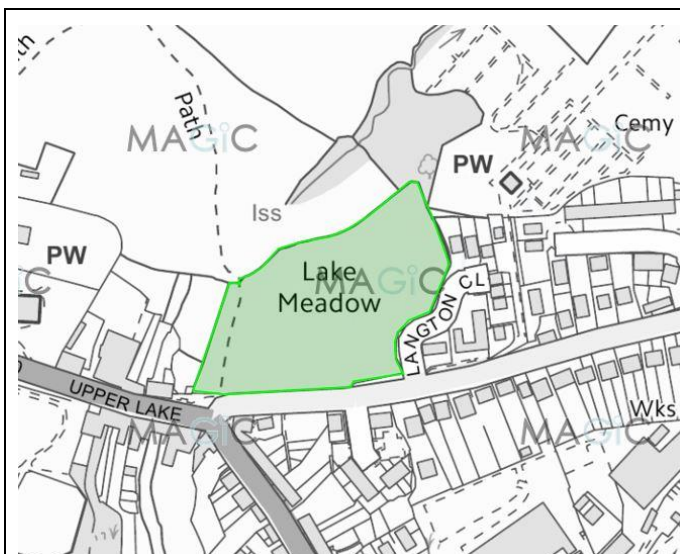

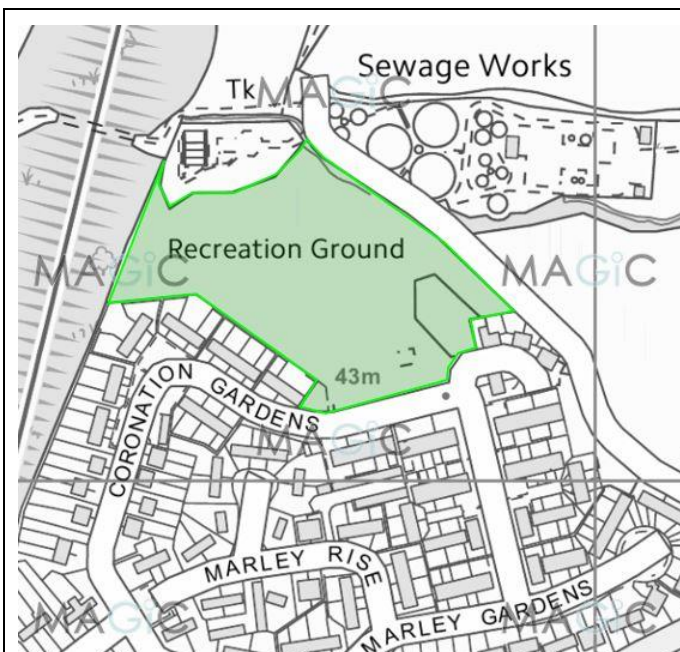

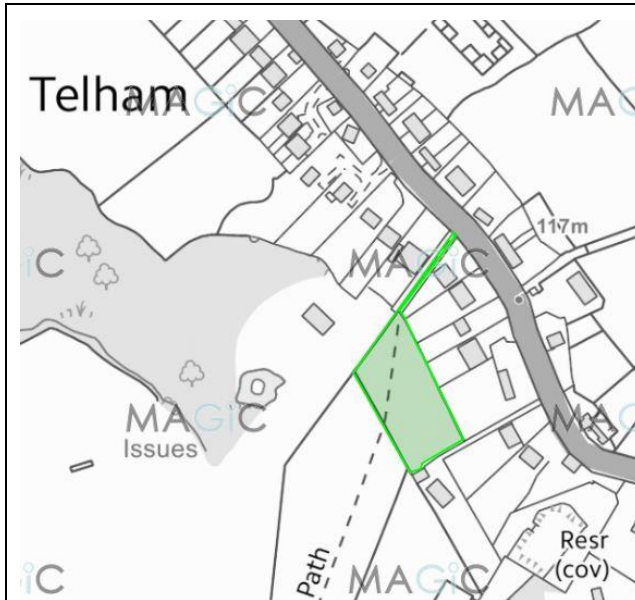

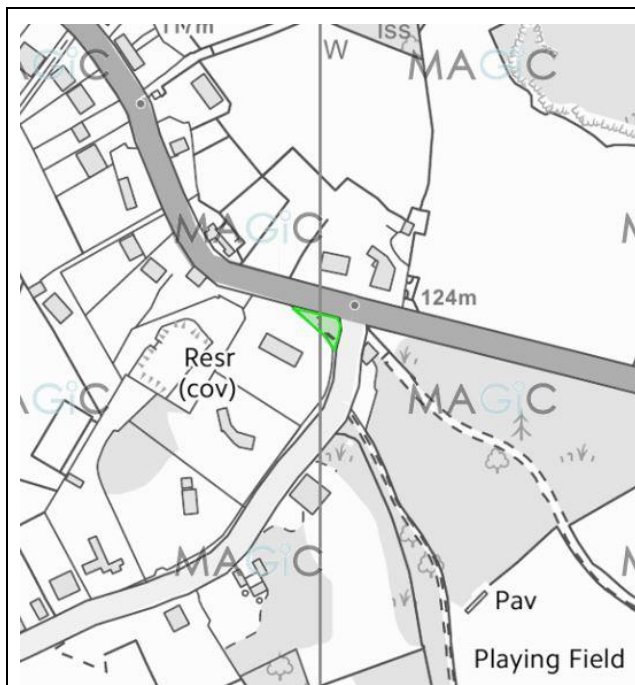

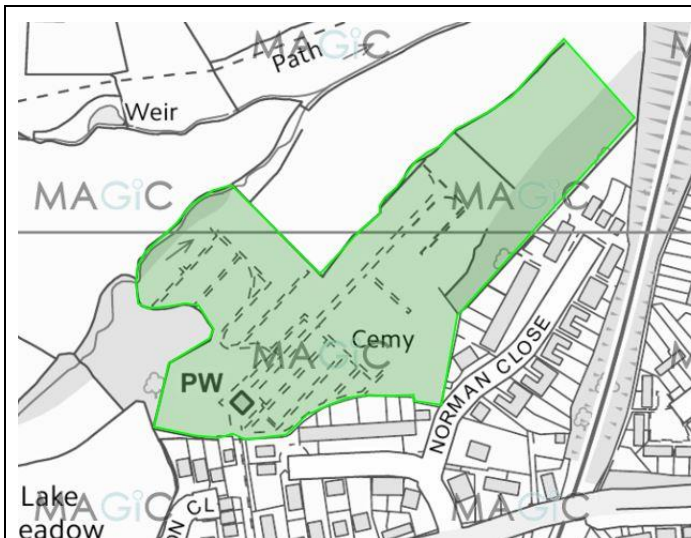

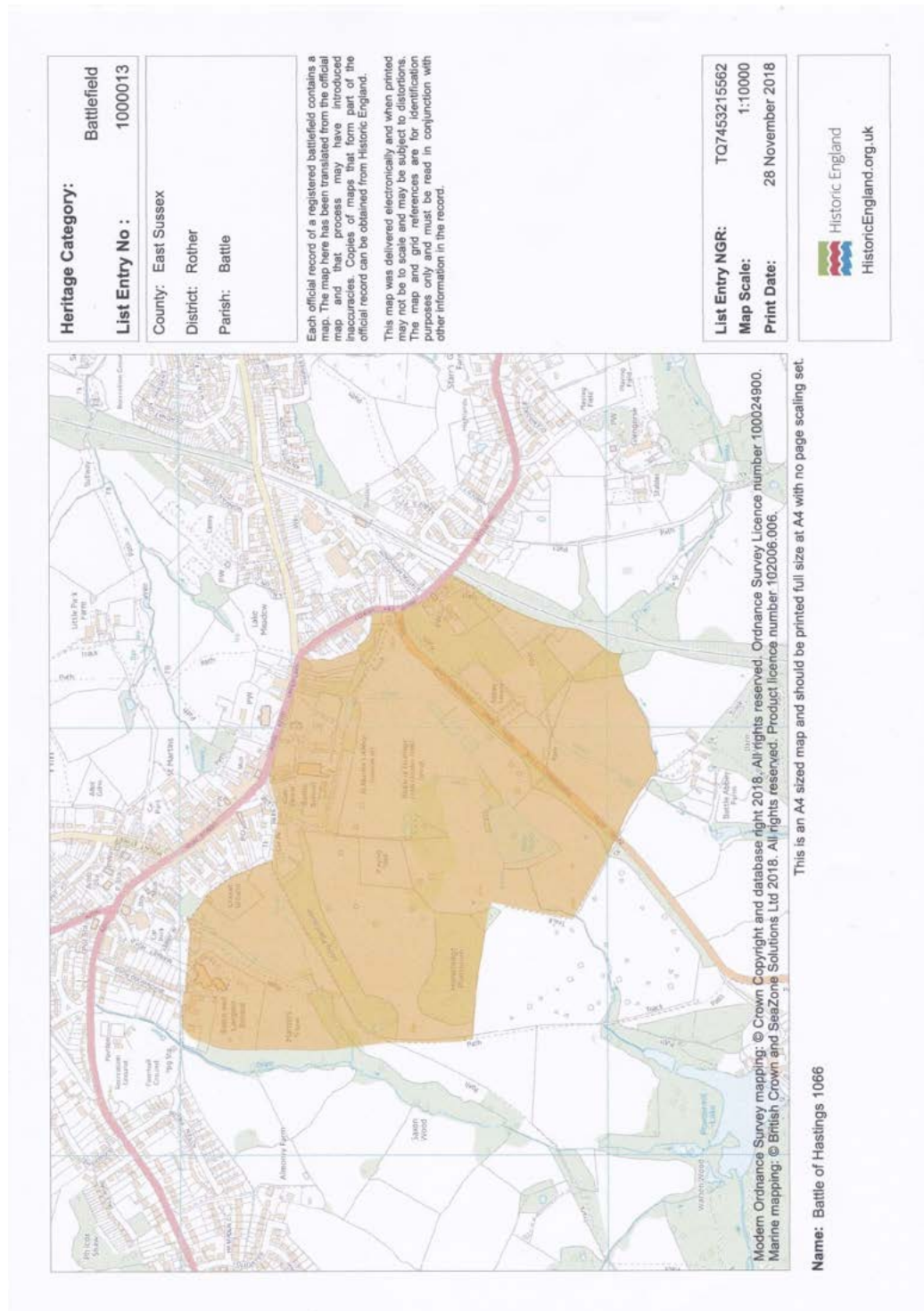
